

Privacy Policy EURObizz Friendz Foundation

This Privacy Policy describes the EURObizz Friendz Foundation's policy regarding the collection, use, store, share and protect your personal data ("Privacy Policy"). This Privacy Policy applies to the eurobizzfriendz.org website ("Website") and all related websites, applications, activities and tools referring to this policy (hereinafter referred to as "Activities"), regardless of how you have accessed, including access or use by using mobile devices. EURObizz Friendz Foundation is responsible for data processing within the meaning of the European General Data Protection Regulation (GDPR).

Scope and consent: By using EURObizzfriendz.org and related forms such as the donation form, you expressly consent to the collection, use, disclosure and retention by us of your personal information as described in this Privacy Policy and our Terms of Use.

EURObizz Friendz Foundation may amend this Privacy Policy from time to time. We advise you to read it regularly. Substantial changes in our Privacy Policy, we will communicate on our website. The amended Privacy Policy will be effective immediately after it was first posted on our website. This Privacy Policy is effective as of January 1st, 2019 and is based on the EU General Data Protection Regulation (GDPR).

2. What personal information do we collect

You can visit our website and make donations without having to log by registering an account. When you decide to give us your personal information, you consent that such information be sent to and stored on our servers.

"Personal Information" is information that can be linked to a specific person and used to identify a specific person. If user data is anonymised or aggregated this data cannot be used to identify a person and are therefore not classified as personal data. We collect the following types of personal data:

Information we collect automatically: When you visit our websites, our applications, activities and tools used or responding to ads or other content, we automatically collect the data sent to us by your computer, mobile device or other equipment that can be accessed. These data include, but are not limited to:

- unique identification of the device or mobile device, type of device or apparatus, information about your geographical location, information about your computer and connection statistics page views, traffic to and from Eurobizzfriendz.org, referring URL, ad data, IP address ; and
- information that we collect through cookies and Web beacons.

Information you provide to us: We collect and store any information you enter on our website or that you provide to us when you use our forms. These data include, but are not limited to:

- information you provide to us when you fill in the form for a donation;
- additional information you may provide to us through social media sites or third-party activities;
- data provided in the context of dispute resolution, correspondence through our websites or correspondence sent to us; and
- information about your location and the location of your device, including unique identifying information of your device if you have activated the service on your mobile device.

Data from other sources: We may receive additional information about you or gather from third parties and add it to our account information. These data include, but are not limited to: demographics, navigation data, additional contact information and additional information about you from other sources, such as government agencies, to the extent permitted by the Dutch law.

Following reports, whether or not via the Reporting Internet Scams Police we can, information (including personal data) on certain disputes between users and advertisers, including by storing the data in the Dispute Database ("GD") of EURObizz Friendz Foundation. The data processed by EURObizz Friendz Foundation in this context is not defined on the basis of their own research through EURObizz Friendz Foundation, but come from users of eurobizzfriendz.org providing by means of a notification information to Eurobizzfriendz.org or to the Reporting Internet Scams and / or relate to existing information on the EURObizz Friendz Foundation website.

3. How we use your personal information

You agree that we may use your personal information collected (see above) for the following purposes:

- To facilitate you in making your donation and support through email or by telephone;
- to prevent potentially prohibited or illegal activities, fraud and security breaches, detect and investigate, and enforce our Terms of Use (think the halting of suspicious conversations via our website);
- to measure and improve our activities, content and ads you tune;

- to contact you via e-mail, push notification, text message (SMS) or by telephone to inform you about our activities as part of EURObizz Friendz Foundation in favor of targeted marketing, updates and fundraising based on your message preferences, or for any other purposes as described in this Privacy Policy; and
- to provide you with information about other activities you have requested, as described when we collected the data.

Data sharing and registration on social media sites: We can sign-on offering activities that allow you to access using your login credentials on other websites to the website eurobizzfriendz.org or related websites. We can also offer activities that allow you to share data with third-party social media websites such as Facebook, Google Plus and Twitter.

If you give us access to personal data stored on third-party websites, the scope of the access to personal data will vary by site and will be determined by your own browser settings and by your permission. If you want to link your account to a third party to your EURObizz Friendz Foundation account, you give us permission to this data, you agree that we can collect data from these third-party websites, use and storage in accordance with this Policy.

Transfer of your personal information to third parties: We may disclose your personal data to third parties in accordance with this policy and applicable laws and regulations. As further described below 4, we make your personal information to third parties for their marketing purposes without your express consent. We may share your personal information with:

- legal authorities on official requests, to possible illegal activity, policy violations, fraud and / or breaches to prevent data security, detect and investigate.
- providers with whom we have contracted to assist us in offering our activities on the website (think of financial activities, marketing agencies and technical support). In such cases, the personal information under the control of eurobizzfriendz.org.
- certain third parties (such as holders of intellectual property rights, regulatory, tax, police and other legal bodies) if compelled to do so abandoned by virtue of legislation or rise under this Privacy Policy. We may share your personal data:
 - To comply with legal obligations or a court order; or
 - If this is necessary for the prevention, detection or prosecution of criminal offenses (such as fraud, deceit or persecution); or
 - If it is necessary to enforce our policies or to protect the rights and freedoms of others.

- Other third parties to whom you have given permission to share your information with eurobizzfriendz.org (eg in the context of a collaboration).
- companies with which we are planning in the context of a merger or reorganization by which we are adopted.

Without limiting the foregoing, we will - in our commitment to respecting your privacy and to keep the website of malicious persons or parties - your personal information otherwise not disclose to law enforcement, other government officials or other third parties without a court order or formal request from the government in accordance with applicable law, unless we believe in good faith that the disclosure of information is necessary to prevent an imminent threat of injury or financial loss or to report suspected illegal activity.

Information you share on eurobizzfriendz.org: On our website, users might have the ability to share information, opinions and other data with other users, making this shared information will be accessible to other users. Since you are on our website and are also able to get in touch with other users, we encourage you to think about how you share your personal information with others. You are responsible for the personal information you share through our website and therefore we cannot guarantee the privacy or security of information you've shared with other users.

We strongly recommend that, if you visit our site from a shared computer or a computer in an Internet café, that you log out of each session. If you do not want the shared computer, and / or remember your data, then you need to delete the cookies and / or history of your website visit.

4. Marketing Purposes

You agree that we may use the information we collect about you, or not, to inform you about activities from EURObizz Friendz Foundation that might interest you.

We do not sell or rent your personal information to third parties for their marketing purposes without your express consent. We may combine your information with information we collect from other organization/companies and use it to improve our activities and functionality and personalize contact with you.

If you do not wish to receive marketing messages from us, you can indicate your message preferences by sending an email to contact@eurobizzfriendz.org, either in your account or received by you message.

5. Cookies

When you use our website, we, or our service providers, may use cookies (data files on the disk of your phone or mobile device) or Web beacons (electronic

images that are placed in the code of a web) on our site.

We use cookies to help us identify you as a user, to provide you with a better user experience on our website (s), to measure fundraising effectiveness and promote trust and safety and ensure safe use on our website.

6. Access, view and edit your personal information

We cannot change your personal and account information. You can customize your data yourself by logging into your account. When you put something publicly, you might be unable to change or delete your message.

If you want to close your account with us, please send us a request to do so. We will process your request within a reasonable time and process your personal information in accordance with applicable law. Alternatively, you can also contact support team of your personal data we store and not directly consulted on EURObizz Friendz Foundation, unless EURObizz Friendz Foundation under the Data Protection Act is not required to provide such access. To be able to meet your request, we need the following from you:

- A signed version of your application that your contact information and your email address is mentioned
- A copy of your valid identity card (after checking EURObizz Friendz Foundation will destroy them)

You can send your request by e-mail to contact@eurobizzfriendz.org with the documentation attached. We can make this a fee of charge; This amount will not exceed the legally permitted amount. If your data is factually incorrect or incomplete or irrelevant for the purposes for which we process your data, you can ask us to modify or delete your data. Such requests will be dealt with in accordance with the Data Protection Act. If you have any questions, please contact us with the subject "Request Privacy Policy" through the Contact form.

7. Protection and storage of your personal data

We protect your data using technical and administrative safeguards to reduce the risk of loss, abuse, unauthorized access, disclosure, alteration and as small as possible. You can think of firewalls, encryption, and physical and administrative controls access to the data and servers. If you still think that there has been an abuse of your account, please contact us via the contact form.

We don't keep personal data longer than legally permitted and delete personal data when they are no longer necessary for the purposes described above.

8. Other information

Abuse and unsolicited communications ("spam"): We will not tolerate abuse of our Website. You do not have permission to add other users of Eurobizzfriendz.org to your mailing list (email or post) or make a donation as if you were them, even when a user has act on behalf of you before, unless the

user has agreed to express them.

If you notice someone makes abuse of our website (spam or spoof emails), we ask you to send an e-mail to contact@eurobizzfriendz.org.

If you think you have discovered a vulnerability in a website hosted by EURObizz Friendz Foundation, we ask you to send us an email to contact@eurobizzfriendz.org with an explanation of the vulnerability discovered by you on our website.

It is not allowed to use our communication tools to send spam or otherwise send content that violates our Terms of Use. For your safety we scan messages automatically and can check for spam, viruses, phishing and other malicious activity or illegal or prohibited content. We do not store messages sent through these means, however, not permanently.

Third Parties Unless otherwise expressly provided in this Privacy Policy, this Privacy Policy applies only to the use and transfer of information we collect from you. Eurobizzfriendz.org has no control over third-party privacy policy may not apply to you. When we work with third parties or use third-party tools to provide certain activities, we will be made explicit privacy policy is applicable to you. We encourage you to ask questions before you disclose your personal information to others.
